Feature :

SECURITY: the plastic straps of the CHAINEXTRA are notched. The adjustment buckles cannot glide on the strap providing reinforced protection for the user.

There is no lateral slit on this glove which means the wrist is completely protected.

COMFORT: the extra smooth plastic straps adapt to all morphologies and guarantee comfort and ergonomics.

EASE OF USE: the plastic straps are removable: they can be bought and changed by the user.

This model can be used on the left or on the right hand (just turn it inside-out)

HYGIENE: an anti-bacterial agent is included in the plastic strap avoiding contamination.

Stainless steel and the plastic straps can be used when in contact with food.

TRACING: each CHAINEXTRA glove is identified by a unique number (1 number = 1 glove): followed by the attribution of the glove, lifetime, repairs ...

DURABILITY: the exceptionnal quality of the CHAINEX chainmesh reduces significantly the number of repairs compared with what is generally recorded on the market.
